- Ref:- 1) Syndicate and Senate decisions to initiate disaffiliation process against your college from RGUHS .
- 2) Govt. of India Ministry of Ayurveda New Delhi letter Dated 06.12.2016 denying permission for taking admission to BAMS course with 40 UG seats at your college for the Academic year 2016-17.
- 3) Karnataka Govt Ayush Department letter dated 14.12.2016 (Not inspecific addressed to Kannada Balaga College, Belagavi)
- 4) Your College letter dated 16.12.2016 addressed to the Registrar.

With reference to the above subject and letter referred above, following facts are brought to your notice and it is for you to bring it to the notice of your management and the concerned students, as it involves glaring and gross violation of RGUHS Ordinances, Government of Karnataka Rules and Government of India specific directions regarding disaffiliation and directing not to admit the students at your college for the academic year 2016-17 to UG BAMS course, respectively.

RGUHS has initiated the disaffiliation process to disaffiliate your college from RGUHS, from the academic year 2015-16 and in that

connection Senate and Syndicate having given consent, called upon the RGUHS to safeguard the interest of students who have been already inducted till the academic year 2015-16. The said fact has been brought to your notice calling upon you not to make admissions of the students at your college.

Secondly, the Ministry of Ayush by its order dated 06.12.2016, has directed your college not to make admissions to 1st year BAMS UG course for the Academic year 2016-17, which is at Ref No.2 above, and as such it is not open for you to make any admission, in violation of the said order.

It is evident that the circular dated 14.12.2016 issued by Ayush Department of Karnataka Government at Ref No. 3 above is general in nature and not being specifically addressed to your college. So you cannot take shelter under the said letter so as to make admissions for the academic year 2016-17 for 1st year BAMS UG course in your college, especially when AYUSH Department of Government of India under Ref No-2 has directed your college not to make any admissions for the 1st BAMS UG course and also intimation by RGUHS to you regarding disaffiliation of your college from the preview of RGUHS has been initiated.

Since the admissions alleged to have been made by you for the academic year 2016-17 for 1st year BAMS UG course at your college based on the general letter at Ref No. 3 above is in gross violation of Government of India Ayush Ministry order dated 06.12.2016 at serial No.2 above, such of the admissions of students cannot be approved by RGUHS, and as such your request for approval of admission under letter at Ref No. 4 cannot be considered and is here by **REJECTED.**
